INVESTIGATION:

On 20 Jul 2011 at 1800 hours, and in continuation of the David KOSCHMAN homicide investigation, the R/D met with Area Three Detective Division Lt. WALSH #359 at his office in regard to the murder of David KOSCHMAN. Upon arrival at Area Three Headquarters, the R/D was informed that a file pertaining to the death of David KOSCHMAN had been located. The R/D also learned that a file belonging to retired Det. Ronald YAWGER was turned over to Lt. WALSH, which also contained copies of reports pertaining to the KOSCHMAN investigation.

Prior to viewing these files, it was learned that City of Chicago Deputy Inspector General William Marback had viewed both files in their entirety.

Lt. WALSH informed the R/D that he wanted to review both files and compare these files to the file originally given to Detectives GILGER and SPANOS in January 2011. An officer from the Legal Affairs (FOIA) Unit, PO Rory O'BRIEN Star 7818, would be present for this review of both files and would be receiving copies of any new reports that were discovered.

The following is a list of reports that were discovered in the file turned over by retired Det. YAWGER:

-One set of Northwestern Memorial Hospital records, which consisted of 40 total pages. There were 38 pages of patient's progress reports, one blank page, and one Chicago Police Department Crime Scene Processing report, prepared by PFI JANICKI #3173, following the autopsy of David KOSCHMAN. This report documented a ME Blood card prepared and inventoried under Inventory #10336727.

The following is a list of reports that were discovered in the file located at Area Three Headquarters:

- Chronological Table of Contents for Homicide HK323454 (2 pages)
- Investigative File Inventory (1 page)
- Crime Scene processing report - VANECKO line up photo, dated 20 May 2004, 1200 hours.
- Crime Scene processing report - MCCARTHY and DENHAM line up photo, dated 20 May 2004,

1245 hours

-General Progress Report (GPR) with the words on front "PCOK406" and "ALAMO 59" and directly underneath "VANECKO" with a possible phone number, "808-3121." On the back of this same GPR are the words, "VDAILEY SISTER SON." The rest of this GPR is blank.

-A copy of a GPR with printing on the left border, which was partially obscured on the copy of the GPR received by Detectives GILGER and SPANOS. In this GPR report, the printing in the left border reads as follows, "At one point, three guys said fuck it, let's go. Victim says, Yeah, you better back down."

-A photo copy of the front of the file turned over by former Det. YAWGER, which is miscellaneous names and phone numbers, as well as miscellaneous information.

-Morgue photos (color)

The R/Ds and PO Rory O'BRIEN were given copies of all aforementioned reports.

After reviewing all of the reports, the R/D determined that none of the new information would have changed the outcome of the investigation.

Subsequent to 20 Jul 2011, the R/Ds learned that City of Chicago Deputy Inspector General William Marback had received from Area Three Detective Division Lt. WALSH, a complete set of copies of both of these files.

This case remains CLEARED EXCEPTIONALLY, CLOSED.
