INVESTIGATION

R/D's, on 20May04, conducted this line up with the above listed subjects who were all of similar height, weight, and appearance. Kevin McCarthy and Craig Denham chose positions one and five respectively as the positions they wanted to stand in. This line up was viewed separately by the witnesses listed in this format.

Michael Connolly viewed this line up at 1200hrs and was unable to positively identify anyone.

Phillip Kohler viewed this line up at 1201hrs and was unable to positively identify anyone.

Shaun Hageline viewed this line up at 1203hrs and stated in summary that he thought the person in position number five, Craig Denham, was the person who was initially placed in handcuffs by the police after the incident and one of the guys trying to break everything up during this incident.

Scott Allen viewed this line up at 1206hrs and identified the person in the number one position, Kevin McCarthy, as the person who was with the girl during this incident and the person who the police placed in handcuffs after the incident. Scott Allen also stated that this person, Kevin McCarthy, was one of the guys who were continually trying to break up the fight. Scott Allen was unable to identify anyone else in the line up.

James Copeland viewed this line up at 1210hrs and was unable to positively identify anyone.

Dave Francis viewed this line up at 1212hrs and identified the person in the number one position, Kevin McCarthy, as the person with the lady who was stopped by the police after the incident. Dave Francis states that he does not remember what this subject, Kevin McCarthy, did during this altercation.
